Our 5280 fellowship is a rigorous and selective nine-month leadership program for emerging leaders in Denver. The program includes theological study, spiritual formation, professional development, and learning from senior leaders in the city. In 2019, we had 21 graduates and 25 new fellows joined the program.

We host public events in partnership with local churches on topics related to theology, work, calling, culture, and a wide array of professional industries. In 2019, we had approximately 1,040 attendees at 9 events with topics ranging from God, energy, and environment; faithful artist; to women work and calling.
